The Code of Maryland is the most current public record of all statutes still in force in the State of Maryland. The Commission to Revise the Annotated Code was appointed by the Maryland legislature on July 16, 1970, led by then-Senate President William S. James.

The Code of Maryland Regulations, often referred to as COMAR, is the official compilation of all administrative regulations issued by agencies of the state of Maryland. While the Legislature of the State of Maryland enacts statutes, it is administrative agencies which adopt, amend, and repeal
